



Privacy Policy Statement

The protection of privacy and the safeguarding of our Clients' personal and financial information is our highest priority. Please view the following Privacy Policy Statement which clearly explains how we, at Nuntius Brokerage & Investment Services S.A. ("Nuntius"), collect, process, store and protect our Clients' information. By opening an account, Client hereby gives Nuntius its consent to such collection, processing, storage and use of personal information by Nuntius as explained below.

Collection of personal information

Nuntius collects the necessary information required to open, transact and safeguard your assets and your privacy and to provide you with the services you require. Protection of personal information

Any personal information you provide us will be treated as confidential and shared only within Nuntius and its affiliates and will not be disclosed to any third party except under any regulatory or legal proceedings. Use of the shared information may also be used to provide professional, legal, or accounting advice to Nuntius. The Client may contact Nuntius for additional information and/or clarifications prior to the signing of this Agreement.

Restriction of responsibility
